Whereas, HVC has tendered a written purchase offer for the above two properties for the sum of \$1.00 with a commitment to return each to the tax roll in an improved condition, now therefore be it

Resolved, that the Common Council hereby finds, in accordance with §159 of the City Charter of the City of Lockport, that a private sale of 155 Genesee Street, Lockport, NY (Tax ID 109.63-2-75) and 169 Genesee Street, Lockport, NY (Tax ID 109.63-2-72) to the HVC for the sum of one (1) and no more dollars is in the best interests of the City of Lockport and, accordingly hereby dispenses with public bidding in connection with this abandonment and sale, and be it further
