**RENEWAL OF TOWN SEWER CONTRACT**

**WHEREAS**, the City of Lockport, pursuant to Agreement dated December 17, 1969, and multiple amendments thereto, accepted sewage from the Town of Lockport sewage collector system, located in certain areas of the Town, and

**WHEREAS**, The City and Town entered into a new agreement dated August 6, 2003, running from January 1, 2002 through December 31, 2006, and

**WHEREAS**, the City and Town entered into an extension of said Agreement dated August 6, 2003, running from January 1, 2007 through December 31, 2008, and

**WHEREAS**, the parties entered into renewals of said contract for additional periods of two years through December 31, 2010, through December 31, 2012, and

**WHEREAS**, the parties wish to renew said contract dated August 6, 2003, for an additional period running from January 1, 2013, through December 31, 2018, and

**WHEREAS**, the Water and Sewer Committee recommend a six (6) year renewal upon the following terms and conditions.

**NOW THEREFORE, BE IT**

**RESOLVED**, that for a period of January 1, 2013 through December 31, 2013, the amount of consideration the Town shall pay to the City is \$596,855.00 per year, and be it further
