Whereas, Resolution No. 101613.5A approved the establishment of an emergency Contract with Yarussi Construction to repair the leaking Gulf Interceptor Sewer, and  
Whereas, possible contamination of exiting soils requires the specialized skills of an environmental Contractor to repair said sewer, now it therefore be it

Resolved, that the Mayor is hereby authorized and directed to enter into a Contract with Mark Cerrone, Inc, PO Box 3009, Niagara Falls, NY 14304 to repair said sewer issue on a time and material basis plus 12%.
