Local Law No. 6 of the year 2011

A local law authorizing amending Chapter 66, Building Construction and Administration §16 Fees

Be it enacted by the Common Council of the City of Lockport as follows:

§66-16 Fees and Fines.

A fee and fine schedule shall be established for the provisions of Chapter 66 by resolution of the Common Council of this City. Such fee and fine schedule may thereafter be amended

from time to time by like resolution. The fees set forth in, or determined in accordance with, such fee schedule or amended fee schedule shall be charged and collected for Building Construction and Administration including but not limited to the submission of applications, the issuance of building permits, amended building permits, renewed building permits, certificates of occupancy/certificates of completion, temporary certificates, operating permits, fire safety and property maintenance inspections, and for fines and other actions of the Code Enforcement Officer described in or contemplated by this chapter.

Effective date

This local law shall take effect immediately.
