Resolved, that §183-23 Parking Prohibited be amended by deleting subsection A (3) Seasonal Permits in its entirety and substituting therefor the following:

(3) Seasonal Permits. Seasonal permits are available for passenger vehicles only and are effective from April 15 through October 15. Seasonal permits shall be issued by the City Clerk upon submission and approval of a completed application prescribed by the City Clerk. The fee for such a seasonal permit shall be \$30.00 and can be paid in cash, check or money order drawn on United States funds payable to the "City Clerk." The fee is non-refundable. In the event a check is returned for insufficient funds, the permit shall be automatically revoked without further notice to the permit holder, and a penalty of \$35.00 shall be charged. A replacement fee of \$10.00 shall be charged for lost or stolen permits. No more than two permits shall be issued per building.

WHEREAS, the City of Lockport owns and operates a combined sewer system in which sanitary waste water and storm water are collected and directed to the City Wastewater Treatment Plant (WWTP) for treatment; and

WHEREAS, the City of Lockport sewer system includes combined sewer overflow (CSO) outfalls which periodically discharge to surface waterbodies during significant wet weather events in order to protect the sewer system from surcharging; and

WHEREAS, the New York State Department of Environmental Conservation (DEC) has promulgated new regulations for the Sewage Pollution Right to Know (SPRTK) Law which require certain public notifications upon discovery of CSO discharges; and

WHEREAS, the City signed a contract with ADS Environmental Services, Inc. on August 24, 2017 authorized by resolution 081617.8E for annual web hosting and cellular service related to monitoring devices installed in the eleven open Combined Sewer Overflow (CSO) that transmit data to the NY-Alert System; and

WHEREAS, the contract between the City and ADS Environmental Services, Inc. has expired and needs an amendment to allow the City to continue using the web hosting services provided by ADS Environmental Services, Inc.; now, therefore, be it

RESOLVED, that the Mayor, subject to Corporation Counsel approval, is hereby authorized and directed to amend the contract between the City and ADS Environmental Services, Inc. and to accept its Proposal for one year of Wireless Telemetry and Webhosting starting on March 22, 2019 for \$3,840.00, amount to be charged to G.8120.54610.

WHEREAS, up-to-date, water infrastructure is vital to protect public health and the environment and to foster thriving communities; and

WHEREAS, most communities have aging and crumbling drinking water and wastewater infrastructure causing damage to roads, streets, schools, homes, and businesses; and

WHEREAS, investing in infrastructure projects creates jobs and build solid foundation for businesses; and

WHEREAS, key members in both the Senate and Assembly, along with the Governor, recognized that local governments need financial support and passed the Water Infrastructure Improvement Act of 2015(WIIA) and the Clean Water Infrastructure Act of 2017 (CWIA); and

WHEREAS, the WIIA and the CWIA have been successful at awarding \$770 million in grants to protect clean water across the state; and

WHEREAS, the City of Lockport has greatly benefited from New York State Water Infrastructure grant program, receiving a grant award in 2016 totaling \$3 million in state assistance to jump-start a drinking water upgrade; and

WHEREAS, only a fraction of eligible projects have been able to receive grants due to a lack of sufficient funding to meet New York State Water Infrastructure needs; and

WHEREAS, shovel-ready projects in the City of Lockport, including a \$3million wastewater project, continue to wait in the wings due to a lack of available State funding; now, therefore, be it

RESOLVED, that the Mayor, subject to Corporation Counsel approval, is hereby authorized and directed to send a letter with this resolution to the Governor, Speaker Heastie, and Leader Stewart-Cousins, Senator Ortt, and Assembly member Norris encouraging and requesting them to continue funding water infrastructure projects and include a \$5 billion-five-year commitment for the Clean Water Infrastructure Act in the SFY 2019-2020 State Budget.

WHEREAS, lead in drinking water poses a serious threat to the health and safety of children,

WHEREAS, there are not safe levels of lead exposure considering that even low exposure to lead contamination in children is associated with learning disabilities, impaired speech, hearing loss, and diminished IQ; and

WHEREAS, lead service lines that connect public water mains to building plumbing systems are the primary cause of lead contamination in drinking water; and

WHEREAS, the removal and replacement of lead service lines is essential to reduce childhood lead exposure and protect drinking water from contamination; and

WHEREAS, the Lead Service Line Replacement Program created through the Clean Water Infrastructure Act of 2017 has expanded the capacity of local governments to invest in this vital infrastructure improvement; now, therefore, be it

RESOLVED, that the Mayor, subject to Corporation Counsel approval, is hereby authorized and directed to send a letter with this resolution to the Governor, Speaker Heastie and Leader Stewart-Cousins, Senator Ortt, and Assembly member Norris encouraging and requesting them to continue funding lead service line replacement and increase the dedicated line of funding for the Lead Service Line Replacement Program to \$100 million.
